GUIDELINES FOR FSBOA SCHOLARSHIP COMMITTEE LESTER AND EUNICE VANCE SCHOLARSHIP FUND

- 1. All applicants for fund must be a full-time prospective or full-time student in a recognized and accredited vocational, college or university school.
- 2. Recipient must maintain at least a "C" average during proceeding year (or if freshman during senior year of high school). See "Qualifications and Instructions" on application form.
- 3. Must apply before cut-off date of application July 15 as ascribed by Scholarship Committee.
- 4. Application is no guarantee that scholarship will be granted.
- 5. The decision of the Scholarship Committee will be final.
- 6. Members of the Scholarship Committee shall be named by the FSBOA President and shall serve on a rotation term of three years.
- 7. Executive Director and President shall serve as advisors to the Scholarship Committee and be notified of and invited to attend all committee meetings.
- 8. Any relative of an applicant shall disassociate him or herself from any discussion or vote upon said applicant.
- 9. Contribution to fund shall be without influence of decision of the Scholarship Committee. No designations as to recipient will be accepted with respect to contributions. Scholarship Committee shall have complete independence in their decisions.
- 10. Scholarship award is limited to sons or daughters of FSBOA members, or sons or daughters of full-time grooms, or full-time grooms.

QUALIFICATIONS AND INSTRUCTIONS

Lester & Eunice Vance Scholarship

The FLORIDA STANDARDBRED BREEDER'S AND OWNER'S ASSOCIATION (FSBOA) will annually grant a scholarship(s) as follows:

Eligibility: The candidate must be a son or daughter of a full-time groom, or a son or daughter of a member of the FSBOA or a full-time groom.

Educational requirements: The candidate must be a senior at any public or private secondary school or a previous high school graduate. He or she should take either the S.A.T. or A.C.T. test and must be recommendable to a college or university by his or her secondary school.

Extracurricular and community service participation: The extent to which a candidate has participated in and contributed to the life and welfare of school and/or community will be taken into account in the assessment of merit.

Standards for consideration: An applicant for this scholarship will be judged by criteria, which, in addition to those listed above, include scholarship, citizenship and leadership. Evidence of character and personality is sought and will be reviewed with care.

APPLICATION FOR CONSIDERATION

Applications will be available at the FSBOA office.

In order to properly advance the interest of the applicant and to conserve the time of the committee, all material presented should be orderly, concise and chronological. All letters should be removed from envelopes and bound for flat review. Exhibits evidencing notable achievements in leadership, literature, athletics, dramatics, community service or other activities may be attached, but the applicant should avoid repetitious accounts.

Applications must include, in the order indicated, the following:

- 1. Two letters of recommendation, neither over 200 words; one from a school official and one from a member of the community.
- 2. A transcript which shows the most recent rank in class and the scores obtained on a national test, either the College Entrance Examination Board Scholastic Test (S.A.T.) or the American College Testing Program (A.C.T.) if applicable.
 - 3. A recent wallet-size photo of the applicant.

Applications that do not conform substantially to the foregoing requirements will not be considered. However, in the event that a candidate's academic achievements are not reflected by grades and tests, other attributes must be provided.

FILING OF APPLICATIONS

Application must be filed prior to July 15 of each year. The recipient will be named by Oct.

ADDITIONAL CONDITIONS

The FSBOA, through this program, seeks students of outstanding merit who show an appreciation of the value of education and who are willing to achieve success.

These rules are subject to change by The Board of Trustees from time to time.
