QUALIFIERS:

--->60-Day Rule Is Now In Effect. ANY HORSE THAT QUALIFIES HERE MUST RACE HIS FIRST START HERE OR BE SUBJECT TO LOSING RACING PRIVILEGES

CLASSES:

--->Classes may be combined to fill a race card and horses may not drop more than 2 classes unless approved by the Race Secretary.

--->When a purse cap is on a conditioned event, it refers to the normal base purse of the class in the last start - excludes 10-horse field purses, Pop-Ups, special events, etc.

*** Any Horse that Qualifies here at Pompano Park must make his First Start Here. ***

CLAIMS:

1.) Cashier's check, money order (payable to PPI Inc.) or money on account required to claim a horse.

2.) State of Florida adds 7% tax on claims. There is no 7% tax if a horse previously is claimed for same price. If horse is entered for higher price, the tax would be on the difference.

3.) Additionally, there is a separate \$35.00 transfer fee which should be a personal check made payable to the United States Trotting Association (U.S.T.A.).

4.) CLAIMED HORSES CANNOT RACE AT ANOTHER RACE TRACK FOR 45 DAYS OR THE END OF THIS RACE MEETING UNLESS APPROVED BY THE RACE SECRETARY.
